



## 2026 Scholarship Program NVCCF Guidelines



### Available Scholarships:

#### \$2500 Brett Torino Heart of Education Award & Student of the Year (Grades 6-12)

- Open to students in grades 6-12
- May be used for tools to help with educational success (i.e., laptops or computers) or towards tuition

#### \$5000 Southwest Specialty Contractors Inc., Building A Future Scholarship (Grades 9-12)

- Open to students in grades 9-12
- May be used towards tuition to a college, university, or trade school as well tools needed paid directly to the school (i.e., books and fees)

#### \$5000 The Power Family, Power of Education Scholarship: (Grades 9-12)

- Open to students in grades 9-12
- May be used towards tuition to a college, university, or trade school as well tools needed paid directly to the school (i.e., books and fees)
- Eligible applicants include diagnosed children, siblings of diagnosed children, or children of a diagnosed parent

### Program Guidelines & Priorities:

#### **\* Applications are due by: July 10, 2026**

\* Seeking **students in grades 9-12** who are **active participants with NVCCF** and are engaged in both NVCCF programs and extracurricular activities, including school-sponsored and non-school-sponsored activities.

*\*\*\*Applicants must be active participants in NVCCF activities, currently receiving treatment, or have received treatment within the past three years*

\* Scholarship funds will be paid **directly to the selected college, trade school, or for the educational tool of choice**, and will not be disbursed to the student. The student is responsible for submitting an invoice for tuition and fees, their student ID number, and the institution's information to the Foundation. A **minimum 30-day notice prior to the tuition due date is required**. A letter of acceptance and a tuition bill from the selected college or trade school must also be provided.
